Reminder: there are two vacant seats; please encourage applications. Seats are filled quarterly. (Jonathan Rice applied last quarter and will join the HRC in June.)

6. **Honorary Naming Policy**

- Draft policy to review – J. Basic

Continued discussion on how to address requests for HRC to support or recommend honorary naming of community individuals:

Chair J. Basic sent the draft policy in an email prior to the meeting

The main points of discussion were:

Reducing, expanding, or eliminating the **length of time a person must be deceased** prior to being nominated

SOLUTION: do not state a time limitation but instead make the time-based criteria dependent on the method of honoring (e.g. permanent plaque vs. temporary banner) wording:
“temporal aspect of memorialization dependent on the method of memorialization” suggestion from O. Brown.

Re-word the "Policy Statement:" last sentence of the 1st paragraph and last paragraph; remove "academic" and replace with terms such as researched, sourced, and cited.

How to let the **public and City departments know that the policy exists** and where to go for assistance (given the HRC will only address internally-nominated people)

The **difference between Commemorating vs. Honoring vs. Memorializing** and how those definitions are applied to our policy creation

Need to add in "and others" to **increase potential honoring methods**

Need to add a **documentation and research statement**

HRC will run draft nominations through test cases wherein HRC volunteers will complete sample forms to work on "debugging" the process

K. Richardson noted the draft policy (with or without the draft nomination form) will go through City legal review prior to a formal acceptance vote by HRC.

Interns would come from the UVA [Institute for Public History](#) or [Internship Placement Program](#)

The current idea is to have an intern translate the existing BPAC Walking Tour historic flyers into an interactive database such as [ArcGIS StoryMaps](#)

Public history interns work through the summer while IPP internships are year-round

J. Basic agreed to develop the project design for the Walking Tour Flyer translation, so the HRC is ready to apply when the internship applications open.

Scholars at Uva have contacted staff regarding interest in the City's Vinegar Hill archival collection-book on the topic is under development.

- There was a question about who should house this collection, O. Brown stated that The Jefferson School should be given the first opportunity to receive the collections; ACHS would gladly take them if JSAAHC declines.
- If JSAAHC chooses to house the collection, the City might consider first digitizing the materials and then executing an agreement that allows City staff and non-City researchers to access the collections and use the items (e.g. photographs, maps, writings) as a co-owner (i.e. no copyright or usage permissions required)
